#### The open enrollment period begins November 1 and ends November 15.

If you do not make any changes through the portal by November 15, your current benefit elections including medical, dental, vision, HSA, life, accident, critical illness, hospital indemnity, whole life, legal, identity theft, and pet insurance will carry over to 2023. **FSA elections will not carry over.** 

All benefit election changes are effective January 1, 2023, to December 31, 2023.

## What's New?

#### Medical Insurance-Plan Design Changes!

- The individual and family deductibles for the HDHP will be increasing to \$3,000 for an individual and \$6,000 for a family due to IRS regulations.
- Pain management will now only be covered through HonorHealth or Innovation Care Partner providers on the Coordinated Care Plan.
- Pre-certification will be required for Hyperbaric Oxygen Therapy.
- Ameriben now requires members to complete a HIPAA form on **myameriben.com** to obtain claims information on enrolled dependents (i.e., your spouse, dependent child, etc.). Make sure to preemptively complete this form so that you can access this information, if needed.

#### New Medical ID Cards for the HDHP!

- If you enroll in the HDHP medical plan, you will be receiving a new medical ID card.
- Your new ID card will reflect the 2023 deductible change-\$3,000 for an individual and \$6,000 for a family.
